Laboratory results are used by the physicians for diagnosis and determination or evaluation of treatments for illnesses of patients. Physicians order Blood Products for patients to treat certain conditions resulting from illness or injury. Provides patient care/services for all stages of the lifespan including pediatrics, adolescents, adults and geriatrics.

Position responsibilities may require working any shift in a 24 hour period, 7 days per week (including holidays) and taking calls.

- I. Assure accurate and timely reporting of all results obtained through performance of laboratory test procedures. Assure accurate and timely issuance of blood products as ordered.
